If an employee receives a positive COVID-19 test result, within twenty-four hours of the bank being informed, the bank will notify both the local public health department and any co-workers, contractors, or suppliers who may have come into contact with that employee. In addition, that employee will return to the workplace only after they are no longer infectious according to the latest guidelines from the Center for Disease Control and Prevention (CDC) and have had a negative test result.
